



## DECLARATION OF CONSENT FOR THE COLLECTION, STORAGE, PROCESSING AND USE OF PERSONAL INFORMATION; AND FOR THE RECORDING, PROCESSING AND USE OF PHOTOGRAPHIC, AUDIOGRAPHIC AND VIDEOGRAPHIC CONTENT

### Subject

As part of your participation in a Max Planck Law event you may be asked to provide information concerning your professional status. The data that you share with us might include your name, institutional affiliation, educational/academic status or attainment, and email address. As part of your participation in a Max Planck Law event you also may be photographed, or audio/video recordings of you may be made.

### Purpose of use

Personal information may be used by the Max Planck Law Network, including producing; editing; storing; archiving; and distributing (inside and outside the network for non-commercial purposes). The purpose of Max Planck Law's collection of personal information is to build up personal contact databases relating to the Network's constituents. Photographic, videographic or audiographic content may be produced; edited; stored; and archived. The purpose of Max Planck Law's collection of this content is to build up an image archive to document the history and activities of the Max Planck Law project; to support public relations activities; for the publication in the Max Planck Law's project activity reports and newsletter; for publication on the internet on the Max Planck Law project's website; for publication on social media platforms; and for disclosure to third parties (press) for press releases.

### Legal basis for data processing

Your consent serves as the legal basis for Max Planck Law's collection, storage, process, and use of this content: for employees in conformity with § 26, para. 2 Federal Data Protection Act (Bundesdatenschutzgesetz – BDSG); for other persons in conformity with Art. 6, para. 1 lit. a GDPR.

### Data erasure and duration of storage

The personal information content, and the photographic, audiographic, and videographic content will be saved in an archive file hosted by Max Planck Law or the MPI with which it is affiliated. The content will be erased in the event of revocation of the consent.

### Risks

When personal information, or when photographic, audiographic, and videographic content is distributed, risks include detectability by search internet search engines, the inability to delete the content entirely from the internet, third-party misuse of the content, and lack of legal protection in the event of misuse of the content outside the EU.
